How does the “Same Sex Marriage” Decision Impact Pro-Life Efforts?

How will the U.S. Supreme Court decision Obergefell v. Hodges making “same sex marriage” the law of the land impact the pro-life movement?

The common thought is that these “same sex marriage” “couples” will desire children, and while adoption might be considered, most likely they will want a child who is biologically related to one of the parents. While the Supreme Court attempted to usurp the Natural Law relating to marriage as one man and one woman, even the Supreme Court cannot change the laws of biology; it still requires a male and a female to create a child. So in order for these “couples” to have children they will have to resort to Assisted Reproductive Technology (ART) that have many unknown risks, as well as being exploitive of women.

Let us follow the process as a same sex male couple attempts to obtain a biologically related child, by using the sperm of one of the partners, and consider the many ways this risks the health of and exploits women.

The Assisted Reproductive Technology journey begins by obtaining an ovum (egg) for in-vitro fertilization. Then the embryo(s) will be implanted in a gestational carrier/surrogate. Often the woman is poor and is offered a large sum of money to entice her into being exploited to meet the perceived needs of the rich as an egg donor and/or gestational carrier.

Egg Donation - Males can provide the sperm; however, an ovum/egg is needed for the in-vitro fertilization process. A woman will need to “provide her eggs” a risky, sometimes even fatal, process.

What are the risks involved in egg donation under the guise of promoting “family equality?”

- Short-term there is the real possibility of serious and potentially life-threatening harm to the health

of the young women making the egg donation. As Assisted Reproductive Technology becomes more and more common, women are speaking out about harrowing personal experiences when undergoing the egg harvesting procedure and recounting both the short and long-term health conditions they suffer. These conditions include ovarian hyperstimulation syndrome (OHSS), loss of fertility, ovarian torsion, blood clots, kidney disease, premature menopause, ovarian cysts, chronic pelvic pain, stroke, reproductive cancers, and, in some cases, even death.

- Once the egg extraction is complete, there is little if any follow-up or tracking with the egg donor. Also, there is no peer-reviewed medical research on the long-term effects and safety of egg procurement on the health of the young women providing their eggs. This makes it difficult, if not impossible, for fertility clinics to provide adequate information for informed consent relative to the health risks involved.
- Often egg donors are enticed to donate their eggs through ads in online classifieds, social media, and college newspapers offering anywhere from \$5,000 to \$100,000 per extraction. These ads are markedly coercive and manipulative of young college-aged women as they directly appeal to their financial need without any mention of the potential health risks involved.

Surrogacy – Once the egg has been obtained and fertilized “in-vitro” a “womb must be hired” to gestate the baby. A surrogate “contract” will be generated, creating yet another set of issues.

- Surrogacy often involves the exploitation of poor and vulnerable women. In many cases, it is the poor who contract or “rent out their wombs” and the rich who can afford to buy. Military wives are often gestational surrogates (which brings up the question: who is paying for her medical care during the pregnancy? Is she receiving medical care through the military? Are our tax dollars paying for this pregnancy?)

- What rights does this surrogate/gestational carrier have to an ongoing relationship with the child she carries?
- What if the pre-baby is determined to be handicapped and the couple wants the baby aborted? What rights does the surrogate have to protect the baby from abortion? Or what if the handicap isn't discovered until birth and the couple doesn't want the baby... what happens to the baby then?
- What are the ethical and practical ramifications of the further commodification of women's bodies; without regulation, including possible fraud committed by surrogacy companies?
- What are the moral and ethical consequences of transforming a normal biological function of a woman's body into a commercial transaction?

The practice is fraught with complexity and controversy surrounding the implications for women's health and human rights. Surrogate services are advertised, surrogates are recruited, and operating agencies make large profits. The commercialism of surrogacy raises fears of a black market and baby selling, of breeding farms, turning impoverished women into baby producers, and the possibility of selective breeding at a price. - "Breeders" interviews women who have served as surrogates, some for money, and others as an altruistic action – in one case the sister of a same sex couple gestated the baby. In effect these women are "renting their wombs" to people wanting to have a child.

The other day the bank teller noticed my Precious Feet Pin and commented she liked my pin, and used to have one herself, but didn't know what happened to it. So I asked her if she would like another one.... she said yes, so I gave her one. (Precious feet pins – don't leave home without a few extras!) I wasn't even officially "on duty" and yet I given an opportunity to "evangelize for life"! Who knows how many people may see the precious feet pin I gave the teller and ask about it? Like a pebble dropped into the pond, the ripples go far and wide.... Do you wear your precious feet pin "all the time?" Do you (like this bank teller) need a replacement for a long-lost or misplaced "Precious Feet Pin?" Where did someone last comment about your Precious Feet Pin, or ask what it was? Do you have an extra pin to share? Contact our office if you need precious feet pins or any other supplies. It comes mounted on an informative fetal development pamphlet that fits easily in a wallet.

We had our annual "America Born to be Free – Too Bad Many Aren't Free to be Born" information table for Life on Friday July 3rd. It was a very busy day at the mall, and as the day was winding down, my energy was spent. As I was putting away the materials a lady stopped at the table and who told me she was 13 weeks pregnant. She wasn't really excited about the pregnancy, so I showed her the 10-12 week "Precious Preborn" model. She kept saying, "I didn't realize the baby was so fully developed." I continued to share several fetal development facts: baby's heart beats at 23 days, baby has brain waves at 44 days, and mentioned that next week – at 14 weeks her baby will have fingerprints, the same fingerprints the baby will have for life. I gave the now excited "Mommy" several pamphlets and a bookmark detailing the fetal development facts I had shared. She left the table excited about her "baby-to-be." We recently posted an article on our Facebook page recounting several babies saved by information tables and the fetal models, especially the "precious preborns" that our table visitors often take with them and show their friends and associates.

July 14th a story broke about Planned Parenthood selling fetal parts. It took several days for the major
