How to Talk to a Friend Who Has Had an Abortion

Recently when a friend discovered that I am involved in the pro-life movement she confided in me that she had an abortion many years ago, and I could tell she still was hurting from the experience. If someone confided in you that she had had an abortion (or a man shared that he had pressured his significant other into having an abortion), would you be able to respond in a way that brings the person closer to healing? Would you know where to direct the person to get more help? How do we as pro-life people respond to such an “opportunity” to provide healing and support?

We all want to say something that will help heal the brokenness and lead to a resolution of the pain. It takes great courage, especially if the person knows you are “pro-life,” to share a previous abortion; perhaps the person is afraid you will be critical or will repeat to others what she tells you. Most important is for her to see you as a true friend who cares about her, that you are not sitting in judgment of her, and that you will hold her information as confidential.

In your response focus on “What is her greatest need right now?” Does she just need someone to listen, a shoulder to cry on? Would a referral to a professional counselor, perhaps a priest or minister, be the best response? Is there a need for immediate crisis intervention? (Along with the number for the “Pregnant? Need help?” 1-800-713-HELP (4357), consider having a number for a suicide prevention or crisis line - 1-800-273-TALK (8255).)

Begin by listening to your friend. Let her tell her story without interrupting her. You don’t have to understand every detail. It is important that she let go of some of the burden she has been carrying and that she no longer feels alone.

Among the things she may mention might be the experience of what happened at the clinic. She may express rage and anger—at the boyfriend, her parents, the clinic personnel, God, herself, and feelings of guilt,

regret, unbearable grief, depression, nightmares, perhaps using alcohol or drugs to try to forget, and even suicidal thoughts. She may share that she became alienated from her boyfriend, family and friends, and that she no longer feels she deserves to be loved or forgiven.

Much as you would like to take all her suffering away, her grief and loss will not disappear after one conversation. Assure her of your friendship. Tell her you will be there for her and help her find healing. Assure her again of your friendship. Promise to be there, not only today, but also in the future. Thank her for having the trust to talk with you; that took courage. Her healing journey has begun.

After hearing her story, consider referring her to one of or more of the resources available for those struggling after an abortion. (Several of these resources are listed at the end of this article.)

On a related note - perhaps your friend has not actually shared her abortion experience; however, you realize your friend is struggling with sadness and emotional turmoil and you suspect that abortion might be the cause. How could you offer help without being obvious about your suspicion?

Perhaps at an appropriate time and place, you might comment, “I found an interesting website that gave me a new outlook on abortion. I never realized the pressures women face in making that decision or how, often afterwards they suffer, grieve and feel alone.” Maybe you leave a pamphlet or other information where she will see it, perhaps on your coffee table if she comes to visit.

If your church has a pamphlet rack, consider offering a post-abortion pamphlet. Contact our office or one of the resources listed on the next page, and we will try to help you obtain materials to assist you in any way we can to help heal the wounds of abortion.

“The Embryo has a Remarkable Ability to Correct Itself”

A study published in the Nature journal and directed by Professor Magdalena Zernicka-Goetz shows that “the presence of abnormal cells in premature embryos does not necessarily indicate a deficiency in the unborn baby.” This research has been carried out in mice; it remains to be seen whether the same mechanisms exist in humans.

Professor Magdalena Zernicka-Goetz decided to carry out this research when doctors told her that “a quarter of the cells in the embryo she was carrying presented with abnormalities.” Following IVF, abnormal cells are detected “in 80 to 90% of premature human embryos,” but to date, “little is known about the fate of these abnormal cells during embryo development.” Professor Zernicka-Goetz “eventually gave birth to a perfectly healthy baby son.”

Following her study, the Professor confirmed that “embryos have a remarkable ability to correct themselves.” The abnormal cells are “eliminated and replaced by healthy cells.” Thus, “this would mean that even if the first indications suggest that the child could have a genetic deficiency because of the large number (...) of abnormal cells in the embryo, this is not necessarily the case.”

From Pope Francis' "On Love, In The Family"

On Friday April 8th Pope Francis issued his Apostolic Exhortation - Amoris Laetitia "On the Love of the Family" Below are several memorable quotes.

"Here I feel it urgent to state that, if the family is the sanctuary of life, the place where life is conceived and cared for, it is a horrendous contradiction when it becomes a place where life is rejected and destroyed. So great is the value of a human life, and so inalienable the right to life of an innocent child growing in the mother's womb, that no alleged right to one's own body can justify a decision to terminate that life, which is an end in itself and which can never be considered the "property" of another human being. The family protects human life in all its stages, including its last." - Paragraph 83.

"A sexual education that fosters a healthy sense of modesty has immense value, however much some people nowadays consider modesty a relic of a bygone era. Modesty is a natural means whereby we defend our personal privacy and prevent ourselves from being turned into objects to be used. Without a sense of modesty, affection and sexuality can be reduced to an obsession with genitality and unhealthy behaviors that distort our capacity for love, and with forms of sexual violence that lead to inhuman treatment or cause hurt to others." - Paragraph 282.

The family is the setting in which a new life is not only born but also welcomed as a gift of God. Each new life "allows us to appreciate the utterly gratuitous dimension of love, which never ceases to amaze us. It is the beauty of being loved first: children are loved even before they arrive". Here we see a reflection of the primacy of the love of God, who always takes the initiative, for children "are loved before having done anything to deserve it". And yet, "from the first moments of their lives, many children are rejected, abandoned, and robbed of their childhood and future. There are those who dare to say, as if to justify themselves, that it was a mistake to bring these children into the world. This is shameful! ... How can we issue solemn declarations on human rights and the rights of children, if we then punish children for the errors of adults?" If a child comes into this world in

unwanted circumstances, the parents and other members of the family must do everything possible to accept that child as a gift from God and assume the responsibility of accepting him or her with openness and affection. ~ Paragraph 166.

A Message from Californians for Parental Rights – Sadly, insufficient signatures were gathered before the March 15 deadline to qualify the California Parental Notification Constitutional Amendment initiative (Attorney General #15-0040) for the Nov. 8, 2016 ballot. Young girls and their families in 38 other states now have parental involvement laws in effect to protect them from Planned Parenthood secret abortions, but not in California.
