UPDATE ON TERRI SCHIAVO CASE

On Friday October 22, a Florida judge refused to allow a new trial to determine whether subjecting Terri Schiavo to a painful starvation death would violate her Catholic beliefs. That is what will happen if her estranged husband Michael is allowed to remove the gastric tube that is providing her with food and water. Circuit Court Judge George Greer said he would not order a new trial requested by Terri's parents, Bob and Mary Schindler. They had requested the new trial saying that recent statements by Pope John Paul II show the Catholic Church opposes removing the feeding tubes of patients like Terri, causing their death. Terri and her family are active Catholics and they say ending her life would violate her Catholic faith. They argue Terri would want lifesaving medical treatment and rehabilitative care. **However, Greer approved a stay that prevents Michael from removing the feeding tube until at least December 6** so the Schindlers can have an opportunity to appeal his decision.

MORE ABOUT STEM CELLS

With the recent passage of California's Proposition 71, providing public funding of both adult and embryonic stem cell research, this topic continues to be a timely one. **Embryonic** stem cell research, of course, is morally unacceptable since it requires the destruction of a tiny human being in order to harvest the stem cells. Some claims are now being made that adult stem cells won't work as well for research since they are not malleable like the embryonic stem cells.

- *A recent Time Magazine article addressed the issue of embryonic stem cells being "malleable." What does that mean?*

Embryonic stem cells (ESC) are cells that have not yet been given their job description, whereas adult stem cells (ASC) have their job description (they are bone, fat, muscle, or skin stem cells, etc.). Because the ESC has not yet been told its job, it is more "malleable," meaning the scientist can more easily make the stem cell do what he/she wants it to do.

- *Is it true that adult stem cells are not malleable?*

On the contrary, researchers have made a lot of progress in molding ASC into different stem cell lines. Take, for example, blood and umbilical cord blood stem cells. They are being used to treat all kinds of diseases. Helen Blau, a leading researcher at Stanford in ASC has documented the malleability of ASC, so it is false to say only ESC are malleable.

- *Is malleability is a good thing?*

In embryonic stem cells, this malleability has also created problems in the lab with tumor formation. Because the ESC hasn't been assigned its job yet and can be molded (the supposedly good feature), it is also difficult for the scientist to control it in the lab, resulting in tumor formations. So overall, malleability is a case of good news and bad news.

So the bottom line is: embryonic stem cell research is not only unacceptable from a moral standpoint; there are problems using embryonic sources even on a practical level.
