MEDIA PRESENCE, PREGNANCY COUNSELING REFERRALS

The month of June brought several opportunities to educate the general public by speaking out on various facets of the respect for the life and safety of the unborn baby in the womb. On June 4th the House of Representatives passed the Partial Birth Abortion Ban, and KPIX San Francisco called within a half hour and requested an “on camera” interview with a representative of the pro-life side of the issue. We were able to meet their request and the Partial Birth Abortion Ban was the lead story on the 11:00 PM news that evening. Then on Friday June 20 Cecelia was on KTVU Ch. 2 in the S.F Bay Area – Segment 2 - speaking on the Unborn Victims of Violence Act, also named the “Laci and Connor Peterson Law.” Both of these interviews were priceless opportunities to present a pro-life viewpoint in a major media market, the San Francisco Bay Area.

California Right to Life regularly receives telephone calls from women seeking abortions, since our name is associated with the abortion issue. As an educational organization, we look at these calls as an opportunity to truly help these women with information and referrals to other pro-life organizations set up specifically for pregnancy counseling or direct assistance to the women in need. One of these organizations is “First Resort,” a pregnancy-counseling center with offices in Oakland, San Francisco, and Redwood City. First Resort provides an ultrasound of the baby and several hours of counseling, and has a high success rate where the mothers decide to carry the pregnancy to term. Our Executive Director Cecelia Cody recently attended a program at First Resort entitled “Only an Hour” which included a talk by the CEO and several staff members, a tour of the facility and a video “After The Choice,” which consists of snippets of women talking about the abortion experience. Your donations allowed California Right to Life Education Fund to purchase a copy of this video for use in upcoming talks to the general public. First Resort also has an abstinence program for grades 7-12 which was explained during the hour. If you would like to borrow the video, or have a youth group that might consider the First Resort Abstinence Program, or would be interested in participating in a future “Only an Hour” presentation at a First Resort Office near you, feel free to contact this office for more information.

A “Save” at a Local Planned Parenthood by Anne Ronco

We recently learned that the Planned Parenthood abortion facility in Daly City is closing. Praise and thank God for that! There is always hope. This closure is the result of twenty years of prayer by local pro-lifers.

Meanwhile, in Concord, a group of determined pro-lifers has been praying weekly for 15 years outside Concord Planned Parenthood. They will not give up. Several months ago, a pregnant girl approached them about receiving help. She learned at her Christian high school that the fetus is a human person. She had a firm conviction not to kill her baby, but she needed some assistance.

She was placed in a Gabriel Project home for 8 months. In April 2003, she had a beautiful, healthy baby boy and is raising him by herself. If the praying pro-lifers had not been outside Planned Parenthood that day, she said, she wouldn't have known to whom to turn for help.

There is a local high school close to this Planned Parenthood, so students are always passing by. This gives the group an ongoing opportunity to interact and hand out brochures. Continued greetings such as "good morning" or "hi guys" create a friendly atmosphere with some students. Greg Watkins, one of the prayer partners, was approached by two students to have a pro-life view interview for their class. That went well.

We all have our own way to fight the culture of death, but it all starts with one thing - prayer. Without prayer we can do nothing and quickly lose the spirit to continue in our ministries.

Pro-lifers pray and educate the public at many local abortion facilities around California. Please consider joining them there! Your presence is a faithful witness for Life. Call our office to link up with other prayer partners in your area.
