Umbilical cord blood transplants give hope to patients

Excerpt from "Be the Match Registry" newsletter

Every mother who donates her baby's umbilical cord blood after birth gives hope to patients. When patients with leukemia, lymphoma and other life-threatening diseases need a transplant, they may be treated with a marrow transplant using a donor from the *Be the Match Registry*[®]. A growing number of patients are receiving a transplant using donated cord blood, which is also listed on the *Be the Match Registry*.

Cord blood basics and the Be the Match Registry

- Umbilical cord blood is one of three sources for the blood-forming cells used in transplants. The other two sources are bone marrow and peripheral (circulating) blood (the two methods of donation for adult donors on the *Be the Match* Registry).
- Umbilical cord blood is collected from the umbilical cord and placenta soon after a baby is born. This blood is rich in blood-forming cells.
- The donated cord blood is tested, and if it meets quality standards is frozen and stored at a cord blood bank for future use. It can then be listed on the *Be the Match Registry* and is available for searching patients.
- The stored cord blood is called a cord blood unit.

The first cord blood transplant was done in 1988. The National Marrow Donor Program (NMDP), which operates the *Be the Match Registry*, began facilitating transplants using donated umbilical cord blood in 2000. Today, nearly 145,000 cord blood units are listed on the *Be the Match Registry*, and the NMDP has facilitated more than 4,700 cord blood transplants.

Cord blood is being used for more patients, both children and adults, although it is used more often in children. This is because a cord blood unit has a limited amount of blood-forming cells. Smaller

patients need fewer cells and larger patients need more cells. Because some cord blood units may not have enough cells for larger patients, those patients sometimes receive two or more cord blood units combined.

Reasons patients' doctors may choose cord blood

- Cord blood may not have to be as closely matched to the patient as a marrow donor, so it may be an option for patients with uncommon tissue types.
- Cord blood units are stored and ready to use, so may be selected if a patient needs to receive a transplant very quickly.
- Studies have found that a transplant complication called graft-versus-host disease (GVHD) is less common and less severe after cord blood transplants.

Reasons patients' doctors may not choose cord blood

- There may not be enough blood-forming cells in a cord blood unit for the size of the patient.
- It usually takes longer for cord blood cells to begin to engraft (create new blood cells and an immune system). Until the cells engraft, the patient is at high risk for infection.
- With a cord blood unit, there are no back-up cells available. For transplants using adult donors, the patient may be able to get a second donation from the same donor if needed, and if the donor agrees. After a cord blood transplant, that option is not available, though doctors may be able to use a different cord blood unit.
- Cord blood is a newer treatment approach for transplant, and doctors do not have as much information about patients' long-term results after cord blood transplants as they do for marrow transplants.

Cord blood donation gives hope

Planned Parenthood's Mammosham

Before you sign up to "race for the cure," maybe it's best to get up to speed on what, exactly, you're running for. A few years ago, the Susan G. Komen Foundation, which raises millions of dollars a year for breast cancer research, admitted that it gives a portion of its proceeds to Planned Parenthood. When people grilled the

Foundation on their partnership, Komen tried to tamp down the controversy by saying that Planned Parenthood "provides vital services."



Considering the news that broke in late February, they might want to change that statement to "refers for vital services," as Planned Parenthood doesn't actually provide mammograms.

Apparently, Planned Parenthood doesn't need our tax dollars for free mammograms--because they don't offer them! Pro-lifer Jill Stanek did some digging, and it turns out that one of the organization's biggest arguments for government funding is completely invalid. "If [the pro-life provisions in this budget] ever becomes law," Cecile Richards has warned, "millions of women in this country are going to lose their health care access, not to abortion services, to basic family planning--you know, mammograms, cancer screenings, cervical cancer."

That's interesting, Stanek says, because not one Planned Parenthood in America performs mammograms. Even the organization's website tells women to "ask your local health care provider, health department, or staff at your local Planned Parenthood center about where you can get a mammogram in your area." Obviously, Richards and friends will stoop to any level of deceit to keep the government checks rolling in.

Meanwhile, what business does Susan G. Komen have funneling money to an organization that:

- a) does nothing to prevent breast cancer, and
- b) lies that it does?

Experts privately acknowledge abortion-breast cancer link, but say it's too political to discuss publicly

Karen Malec, the Coalition's president, said, "During the last 21 months, four epidemiological studies and one review reported an ABC link. [1-5] One study included National Cancer Institute branch chief Louise Brinton as co-author. [3] We count nearly 50 published epidemiological studies since 1957 reporting a link. Biological and experimental studies also support it.

"Experts proved in medical journals that nearly all of the roughly 20 studies denying the link are seriously flawed (fraudulent). Like the tobacco-cancer cover-up, these are used to snow women into believing abortion is safe." [6-16]

Professor Joel Brind and his colleagues reported a "30% greater chance of developing breast cancer" in their 1996 review and meta-analysis of worldwide data. [17] He said recently:

"If we take the overall risk of breast cancer among women to be about 10% (not counting abortion), and raise it by 30%, we get 13% lifetime risk. Using the 50 million abortions since Roe v. Wade figure, we get 1.5 million excess cases of breast cancer. At an average mortality of 20% since 1973, that would mean that legal abortion has resulted in some 300,000 additional deaths due to breast cancer since Roe v. Wade."

Brind's estimate excludes deaths from the use of abortion to delay first full term pregnancies - a recognized breast cancer risk.

In 2002, Angela Lanfranchi MD testified under oath in a California lawsuit against Planned Parenthood that she had private conversations with leading experts who agreed abortion raises breast cancer risk, but they refused to discuss it publicly, saying it was "too political."
