Parent Right to Know Initiative

IN CALIFORNIA, a child under 18 can't get an aspirin from the school nurse, get a flu shot, or have a tooth pulled without a parent knowing. HOWEVER, surgical or chemical abortions can be secretly performed on minor girls -- even *13 years old or younger* -- *without parents' knowledge*.

PARENTS are then not prepared to help young daughters with any of the serious physical, emotional, or psychological complications which may result from an abortion or to protect their daughters from further sexual exploitation and pregnancies.

A study of over 46,000 pregnancies of school-age girls in California found that *over two-thirds* were impregnated by adult men whose mean age was 22.6 years.

Investigations have shown that secret abortions on minors in California are rarely reported to child protective services although these pregnancies are evidence of statutory rape and sexual abuse. This leaves these girls *vulnerable* to further sexual abuse, rapes, pregnancies, abortions, and sexually transmitted diseases.

PROP 73 will require that one parent or guardian be notified at least 48 hours before an abortion is performed on a minor daughter.

PARENTS AND DAUGHTERS in more than 30 other states have benefited for years from laws like Prop 73. Many times, after such laws pass, there have been substantial reductions in pregnancies and abortions among minors.

When parents are involved and minors cannot anticipate secret access to free abortions they more often avoid the reckless behavior which leads to

pregnancies. Older men, including Internet predators, are deterred from impregnating minors when secret abortions are not available to conceal their crimes.

If she chooses, a minor may petition juvenile court to permit an abortion without notifying a parent. She can request a lawyer to help her. If the evidence shows she is mature enough to decide for herself or that notifying a parent is not in her best interests, the judge will grant her petition. The proceedings must be confidential, prompt, and free. She may also seek help from juvenile court if she is being coerced by anyone to consent to an abortion.

POLLS SHOW most people support parental notification laws. They know that a minor girl -- pregnant, scared, and possibly abandoned or pressured by an older boyfriend -- needs the advice and support of a *parent*.

PARENTS have invested more attention and love in raising their daughter, know her personal and medical history better, and care more about her future than strangers employed by abortion clinics profiting from performing many abortions on minors.

A minor still has a right to obtain or refuse an abortion, but a parent can help her understand all options, obtain competent care, and provide medical records and history.

An informed parent can also get prompt care for *hemorrhage, infections* and other possibly *fatal* complications.

Latest In Stem Cells

The umbilical cord blood and adult stem-cell breakthroughs keep on coming. Human trials are ongoing for heart disease, spinal cord injury, eye afflictions, and many other diseases. And here's a bit of potentially very big news: A just-published peer-reviewed study (*Cytotherapy*, Vol. 7. No. 4 (2005), 368-373) reports that scientists have used umbilical cord blood stem cells to *restore feeling and mobility to a spinal cord injury patient*. The patient had been paraplegic (complete paraplegia of the 10th thoracic vertebra) for 19 years. The researchers report that after receiving an infusion of umbilical cord blood stem cells,

[t]he patient could move her hips and feel her hip skin on day 15 after transplantation. On day 25 after transplantation her feet responded to stimulation. On post operative day (POD) 7, motor activity was noticed and improved gradually in her lumbar paravertebral and hip muscles. She could maintain an upright position by herself on POD 13. From POD 15 she began to elevate both lower legs about 1 cm, and hip flexor muscle activity gradually improved until POD 41.

In other words, she regained feeling and some mobility after nearly 20 years of being paralyzed. (Similar results for patients with spinal-cord injuries have been reported in human trials in Portugal using the patients' own olfactory (nasal) stem cells--these studies have not yet been published in a peer-reviewed journal, though the very promising results in the first American patients have been testified to in a Senate subcommittee hearing and featured on the PBS television series *Innovation*.)

It is true that we have to be cautious about this. One apparently-helped paralyzed patient does not a broad efficacious treatment make. Also, the authors note that the woman also received a laminectomy (spinal surgery to release pressure) that could have provided her some benefit. Still, they report, not only did their patient regain feeling after years of numbness, but "41 days after [stem cell] transplantation" testing "*also showed regeneration of the spinal cord at the injured site.*" (emphasis added)

This offers tremendous hope for paralyzed patients and their families.

Italian Coma Victim Awakens After Two Years, Says He Heard Everything

Rome, Italy (LifeNews.com)—A man who had been placed in a coma for two years as a result of an automobile accident recently awoke and told doctors and his family that he heard and understood

everything going on around him during the time.

Salvatore Crisafulli, a father of four, describes his case as a "miracle" proving that lost causes are not hopeless. "The doctors said that I wasn't conscious, but I understood everything and I cried in desperation,"

Crisafulli, who is 38, told Italian media outlets Thursday.

Although the situations are not entirely similar, Crisafulli's brother Pietro called the recovery "an Italian Terri Schiavo case."

He emerged from the coma three months ago and began speaking recently -- his first word was "Mamma."

The news comes at the same time as a national bioethics committee in Italy put forward guidelines saying that incapacitated patients should be provided normal medical care, including food and water.

"To feed an unconscious patient through a tube is not a medical act," the committee's president, Francesco D'Agostino, said, according to a Reuters report. "It's like giving a bottle to a newborn baby who can't be nursed by its mother ... And then we reflect on the Schiavo case. The woman was left to die of starvation."

"My brother speaks and remembers. I don't expect that he will be like he was, but it's already a miracle," Pietro told the Italian *Corriere della Sera* newspaper. "And to think that some doctors said that it was all useless and that he would be dead in three, four months."
