Pro-Life Effort in Kenya, AFRICA

In May 2005, two of our members and longtime volunteers with California Right to Life Education Fund (since our beginning), Mike and Anne Ronco, journeyed to Kenya and Tanzania visiting Maryknoll hospitals, schools, and parishes. Below is an account of their trip.

While in Kenya, we had an opportunity to visit one of the major slums called Kabura. What we saw is hard to imagine; there are over 70,00 people in this slum which covers less than 400 acres. The people have no piped in water, sanitation or electric power.

We went to Kabura's only church; a Catholic Church named Christ the King. The first person we were introduced to was a woman named Domtila. Would you believe it, she is the Respect Life Coordinator for her parish!

Domtila shared that in July she would be putting on an area Respect Life Conference, but she was very short of any materials for the conference.

When we returned home, we contacted California Right to Life Education Fund and, along with supplies we already had, we packed and mailed about 29 pounds of literature: pamphlets, bookmarks, newspaper articles to Domtila. We were also able to purchase 300 Tee Shirts for the youth at the conference. What an honor it was to help Domtila with her ministry half way around the world!

We had Domtila select one pamphlet that we would have translated into Swahili. She selected a pamphlet "*Before You Choose, Learn the Facts.*" I called Paul Broughton of LifeCycle Books and he has agreed to partner with us to produce this pamphlet. We will translate it into Swahili and use new pictures that are more reflective of the African Culture. This is very exciting to us and we are anxious to work with Paul and Domtila on the project.

One last bit of news that is very encouraging. While visiting St. Mary's Hospital in Naurbrozi we spent some time with Father Bill Fryda. Fr. Bill, a graduate of John Hopkins and also an ordained Jesuit priest, is the founder of St. Mary's Hospital. Five years ago it was only an empty five-acre lot; now it is a full-service teaching hospital that serves over 1,000

outpatients a day. The maternity ward, financed by members of St. Bonaventure's Catholic Church in Concord, delivers 30 babies a day. There are several small signs throughout the hospital that state that NO abortions are done at this facility.

In closing, Anne and I encourage you all to never abandon the cause of life. There are people all over the world joining us.

Pro-Life Bumper Sticker Prompts Teenage Mom to Reconsider Abortion

Millinocket, ME (LifeNews.com) -- When pro-life advocates Dave and Mary Labun left their house, they didn't expect to see a note on their car. What they found surprised them. In their hands they held not a complaint from a neighbor or a police citation. Instead, a teenager told them their pro-life bumper sticker prompted her to reconsider a decision to have an abortion.

Maine residents Dave and Mary Labun sport a sticker with the phrase "Abortion Stops a Beating Heart," on their vehicle. The unnamed girl left the couple the following note:

Hello, This might be very weird, but I wanted to thank you. I'm not sure what you believe in, but I'm a strong believer in God, and right now I am 17 and pregnant. And on my way to school one day, I was really wondering what to do -- I was really thinking about abortion, because I was scared.

As that thought came to mind, I walked past your car, and happened to look over and saw your bumper sticker, "Abortion Stops a Beating Heart." My heart dropped. I believe God was talking to me, through that sticker, and I also believe I will never think about it again. I'm going to keep my baby, and I'm not that scared any more.

Stem Cell Update

The media continues to mislead people by trying to make our citizenry fund the unethical and immoral **embryonic** stem cell research (ESCR.) We daily hear such statements as, "This is such promising research - it seems like there's a new breakthrough every day." This is an erroneous and misleading statement... There have been **NO** treatment "breakthroughs" using embryonic stems cells. Yet we still hear attempts to push through "Emperor's Clothes" funding legislation. There are **NO** cures and **NO** treatments yet developed as a result of ESCR, and knowledgeable serious scientists say there won't be for a long time.

Meanwhile, treatments using **adult stem cells** continue to increase. Below are a few that were highlighted in the August 2005 issue of Reader's Digest. Other exciting developments show that embryonic-like stem cells are in umbilical cord blood,

and recent research shows promise in harvesting stem cells from the placenta.

1. Heart - Using bone marrow stem cells, Douglas Lorscheider, MD, chief of cardiovascular research at Caritas St. Elizabeth's Medical Center in Boston is rebuilding heart muscle for heart attack victims. This is one of several locations performing this treatment.

2. Cornea - Kohji Nishida, MD and coworkers at Japan's Osaka University Medical School Department of Ophthalmology implanted mouth tissue stem cells into the cornea of a nearly blind man, who can now see clearly a year later.

3. Skin - Using a postage stamp sized biopsy, doctors can now grow enough replacement skin to cover the entire body. The product is called "Epicel" from Genzyme, Cambridge, MA.

4. Knee cartilage - Genzyme also produces "Carticel," a lab-grown human knee cartilage. It gives orthopedic surgeons an alternative treatment for injured knees. On reading about Carticel at the Genzyme web site we find there is an even better product mentioned - MACI. Both products involve growing new cartilage from a small piece of the patient's own cartilage.

5. Bladder - Using lab-grown ear cartilage, Anthony Atala, MD, professor of surgery at Wake Forest University is working to cure incontinence. He has also grown a human bladder and with FDA approval will begin testing it as a replacement bladder for patients who have lost their own due to cancer or injury.

6. Kidney - David Hume, MD, professor of internal medicine at University of Michigan in Ann Arbor, has created bio-artificial kidney to treat the severely ill. It is part conventional prosthetic and part lab-grown cells.

The Parents Right to Know initiative will require that at least one parent be given 48 hours notice that their minor daughter (under 18 years of age) is scheduled to have an abortion. The parents are then assured of being able to provide advice and counsel to her during this difficult time in her life. The scheduled provider of the abortion will be required to make the notification.
